### ENTRY REQUIREMENT

#### a. General Entry Requirements

The following are general requirement for the Preliminary Vocational and Technical Education Programme.

-Candidates are required to possess a minimum of four (4) credits including English Language in SSCE, GCE, NABTEB, (NTC or NBC), C & G I or II, Federal Craft Training Certificate, TCII or any other equivalent qualifications as may be approved by the University.

### SPECIFIC REQUIREMENTS

#### i. Business Technology and Entrepreneurship Education

Four (4) 'O' Level credits including English Language and any three (3) of Mathematics, Economics, Accounting, marketing, Commerce, ICT or any business/vocational subject

#### ii Agricultural Technology and Consumer Science Education

Four (4) 'O' Level credits that must include English Language, any three (3) relevant subjects from Chemistry, Biology, Agricultural Science, Food & Nutrition, Textile & Clothing, Home Economics.

#### iii Industrial Technology Education

Four (4) 'O' Level credits including English language and any other three (3) of Mathematics Technical Drawing, Physics, Chemistry, ICT or NTC subjects.

NB Candidates who have less than five (5) credits in relevant 'O'level subjects MUST have to make up the subjects before they are placed into their desired programme.

Candidates stand the advantage of being guided on JAMB registration and are also given intensive coaching to enable them to obtain maximum scores that are required by the university management.

### METHOD OF APPLICATION

- (i) Applications are available only on the online platform. Interested candidates are to visit the Benue state university website <https://portal.bsum.edu.ng/PVApplication.jsp>
- (ii) Click on Preliminary Vocational and Technical Education and complete the pre-registration information and submit. An application number will be generated.
- (iii) Print a copy of the pre-registration form and proceed to the bank and pay a non-refundable application fee of five thousand Naira (N5,000.00) using the generated application number.
- (iv) After payment, applicants would be expected to revisit the Benue State university portal under application and click on Preliminary Vocational and Technical studies to complete the application form and submit.
- (v) Applicants are to print a copy of the completed form and submit to the office of the coordinator Preliminary Vocational and Technical Education with photocopies of the following:
  - (a) Payment receipt
  - (b) NABTEB, WAEC, NECO, GCE result(s).
  - (c) Local Government certificate of origin
  - (d) Birth Certificate
  - (e) Three passports
